In addition to the terms of Carnival Cruise Lines Travel Agent Agreement, by submitting this Form, Travel Agency also hereby agrees to abide by the Carnival Cruise Holiday Booking Terms and Conditions, a copy of which can be found at www.carnival.co.uk, as well as Carnival's sales, payment and other policies and procedures published from time to time and available on www.GoCCL.co.uk or otherwise advised to Travel Agency. It is Travel Agency's responsibility to check for updated policies and procedures as published by Carnival on www.GoCCL.co.uk from time to time. Without limiting any provisions of the Travel Agency Agreement, Travel Agency agrees:

- that it is responsible for ensuring that it holds all necessary licences and meets all applicable bonding requirements to sell Carnival products;
- to fully comply at all times with The Package Travel, Package Holiday and Package Tours Regulations 1992, The Civil Aviation (Air Travel Organiser's Licensing Regulations 2012) and all other applicable laws, as well as applicable industry codes of practice, such as in the case of an ABTA member, the ABTA Code of Conduct;
